- If a parent does not wish for their child to participate they must pick them up, that day, at 12:00 PM from HSES.
- Parents are welcome to join their students at Dairy Ashford Roller Rink
- Only Lower School students may skate. Parents may pay to skate if they wish.
- The skating rink has been reserved as a private party for HSES. It will be closed to the general public from 1:00-3:00 PM
- There will be 10 teachers riding on the bus with the students
- There will be 10 teachers supervising the students at the skating rink.
- The skating rink will provide skates or roller blades. Students may bring their own skates.
- A beverage, cookie and Chex mix will be served.
- Students are not permitted to bring additional money for video games, food or drinks.
- Students should not bring backpacks or lunch kits to the Roller Rink.
- Hot lunch will be served on the normal schedule. If your student is brining a lunch please send it in a disposable bag.
- Skate time will be from 1:00-3:00 PM.
- Afternoon Dismissal: We request that you pick your child up at 3:00 PM from Dairy Ashford Roller Rink.
- Transportation by bus will be provided back to HSES only for students who normally attend after school CEC care or a Ready U enrichment program.
